### **3. Rules, Guideline for Publication:**

By submitting a text to the International Academic Publishing House (IAPH), the author(s) warrant that the text has neither been published previously nor is currently being considered for publication elsewhere. They also warrant that the sources of any ideas and/or words in the text that are not their own have been properly attributed through appropriate citations and/or quotes. Authors' names are not concealed. It is clearly advised to the authors to avoid any copying and pasting while preparing the text. Submitted text should contain sufficient details and references to permit others to replicate the work. Fraudulent or seemingly inaccurate statements may qualify as unethical behavior/practice and may, therefore, be considered unacceptable. Submitted text must showcase the novelty in thought(s) and content(s). Authors should ensure that any study involving human or animal subjects conform to relevant national, local and institutional guidelines and requirements (e.g., WMA Declaration of Helsinki, NIH Policy on Use of Laboratory Animals, EU Directive on Use of Animals) and must confirm that approval has been sought and obtained from the appropriate ethical committees and/or review boards. Authors should also confirm obtaining informed consent of human subjects and respect their privacy. All the authors must declare any potential conflict(s) of interest, for example, where ever an author has a competing interest (real or apparent) that could be considered or viewed as exerting an undue influence on his/her duties and/or roles at any stage during the publication process. All the authors must disclose in their text any financial or other substantive conflict of interest that might be construed to influence the results or interpretation of their text. The corresponding author(s) must ensure that all the co-authors have seen and approved the final version of the text and have agreed to its submission for publication. Once enough evidence(s) is found to prove any misconduct on the part of any of the authors, the author(s) will be informed about their misconduct to clarify the matter. If the author(s) is unable to defend the case satisfactorily, the article is liable to be rejected/ retracted by the journal and removed subsequently from the website.

#### **Plagiarism is defined as follows:**

- (i) Changing the words but replicating the sentence structure of a source without providing a reference is considered plagiarism.
- (ii) Copying words or ideas from someone else without providing reference is considered plagiarism.
- (iii) Using someone else's work as your own is unethical.
- (iv) Putting your name on someone else's essay or effort is considered plagiarism.
- (v) Failure to enclose a quote inside quotation marks.
- (vi) Falsely identifying the source of a quote.

(vii) Plagiarism cannot be prevented only by altering the terms of a source. No matter how significantly you modify the context or presentation of a source's basic concept, you have plagiarised it if you have not mentioned it. This is true even if you have kept the source's essential idea. The majority of instances of plagiarism, on the other hand, may be prevented simply by crediting sources.

Plagiarism may typically be avoided by simply declaring that particular content has been taken and giving your readers the information they need to locate the original source.

**Declaratory statement against plagiarism, upon submitting a work for consideration for publication in the International Academic Publishing House (IAPH), the author/authors (all authors of the article) guarantee that:**

(i) To ensure that all sources consulted in the writing of the article or project have been recognized and properly cited, writers, sign a declaration before submitting their work for publication.

(ii) Using another person's idea or published work in order to pass it off as one's own is plagiarism, and authors are well aware that doing so is unlawful and bad. They also understand what plagiarism is and how it works. The students are also aware that plagiarism is defined as the intentional appropriation of another person's idea or published work in order to pass it off as one's own.

(iii) Unless otherwise stated, the author(s) take full responsibility for the work they have done, the material in the article, and any errors or omissions in the citations.

**(iii) When a single author mentions a journal article's reference:**

Madhu, N. R. (2011). Pineal-adrenocortical interactions in domestic male pigeons exposed to long and short photoperiods and exogenous testosterone propionate. *Journal name (Italics Font)*. 44(4): 349- 362. (Note: It means, the volume is 44, the issue is 4, and the pages are 349-362).

**(iv) When a reference is cited as dual authors from a journal article:**

Madhu, N. R., & Manna, C. K. (2011). Pineal-adrenocortical interactions in domestic male pigeon exposed to long and short photoperiods and exogenous testosterone propionate. *Journal name (Italics)*. 44(4): 349-362.

**(v) When more than two authors are mentioned in a citation from a journal article:**

Madhu, N. R., Maiti, A. K., & Manna, C. K. (2011). Pinealadrenocortical interactions in domestic male pigeon exposed to long and short photoperiods and exogenous testosterone propionate. *Journal name (Italics)*. 44(4): 349-362.

**(vi) When Referencing a Patent:**

Madhu, N. R., Maiti, A. K., & Manna, C. K. (2011). Pinealadrenocortical interactions in domestic male pigeon. U.S. Patent No. 1234567.
